Role Title: Integrated CKD Clinical Lead

Remunerated time: 1 session/4 hours per week

General information

Improving lives by supporting professionals in the delivery of kidney care and research, the UK Kidney Association is the leading professional body for the UK kidney community. We welcome members working in clinical kidney care, treating and caring for people with kidney disease, and those working in research, or related sciences and fields.

The UK Renal Registry is the part of the UK Kidney Association responsible for the collection, analysis, management and development of a high quality clinical renal database. We use data submitted from the 71 adult and 13 paediatric kidney centres across the country to create the database. The information, in the form of data and reports, is a shared resource used to develop research into kidney disease to improve the quality of care for renal patients.

Job Purpose

The Integrated Chronic Kidney Disease (CKD) project aims to optimise the delivery of an early CKD prevention model as part of a cardio-renal-metabolic strategy across multiple geographical locations. The model sets out an approach to the identification and treatment of people with early-stage CKD. The treatment of these people living with CKD will mainly remain within primary care.

The Integrated CKD Clinical Lead will be responsible for leading and coordinating this project, overseeing and advising on a number of possible workstreams. They will ensure links with a wide range of stakeholders across Integrated Care Boards and the British Cardiovascular Society, both primary/community and secondary care, building networks and championing engagement. They will work closely with and be supported by the UKKA Education Project Manager.

Influencing & Stakeholder Engagement

- Work closely with the education project manager to ensure the development of a strategic project plan, providing leadership, oversight and support in its delivery.
- With the Education Project Manager, liaise with UKKA Special Interest Groups
 (SIGs), Professional Groups and staff to develop the clinical and economic case for
 prioritising early chronic kidney disease (CKD), aimed at informing and influencing
 key stakeholders including Integrated Care Board (ICB) leads and the All-Party
 Parliamentary Kidney Group (APPKG).
- Advocate for a unified national cardio-renal-metabolic (CvRM) strategy by engaging leaders from related professional bodies (e.g. British Cardiovascular Society, Diabetes UK, Primary Care Diabetes Society, Primary Care Cardiovascular Society) to align messaging and policy objectives.
- Support the education project manager in the development and clinical review of national briefing materials and slide decks to promote stakeholder engagement, covering:
 - Case for change (e.g. priorities, high-risk populations, multimorbidity, health inequalities, disability-adjusted life years)
 - Strategic fit (e.g. shift from hospital to community, disease to prevention, analogue to digital)
 - Value for money (e.g. early identification and management with medication vs. haemodialysis costs, primary care vs. secondary care management, avoidance of crash landers)
 - Patient benefit (e.g. improved quality of life, reduced hospitalisation, delayed progression)
 - Commissioning support (e.g. business cases, governance frameworks, crossbudget funding models)

Guidelines

 Coordinate with the UKKA Guideline Leads and leaders from cardiology and diabetes organisations to develop clinically-relevant and practical outputs for primary care and



commissioning audiences (e.g., hypertension, cardiovascular disease prevention, SGLT2 inhibitors, Finerenone, GLP1 agonists, joint guidelines on diabetes and CKD)

People & Skills

- Liaise with the UKKA Education Project Manager, clinical experts, and primary care representatives to guide the development of role-specific education resources.
- Oversee the review, refinement and, with attribution, the sharing of existing training materials; identify and address content gaps.
 - Curate high-quality existing resources to showcase in a national knowledge hub.
 - Support the clinical validation and development of new e-learning content for pharmacists, nurses, and GPs to fill gaps.

Patient Education

- Collaborate with the UKKA Patient Information Committee and kidney charities to coordinate where they exist, and develop new patient education materials where not, always building upon and refining existing resources.
- Ensure consistency between professional training and patient-facing materials, particularly on topics such as early detection, medication and self-care.

• Data & Evaluation

• Liaise with the UK Renal Registry to identify, define, and clinically validate a core set of indicators, data sources, and opportunities to create data linkages.

Developing work with up to 4 new kidney centres with their ICBs

Whilst this project intends to work with and build central resources for all kidney centres throughout the UK, it will aim to identify and support 4 new kidney centres without significant experience in integrated CKD as they build the early stages of their projects.
